Candidates are required to bring all original documents about their educational qualification/experience and other relevant documents along with their self attested photocopies at the time of interview. Candidates are also required to bring any Identity proof along with self-attested copy i.e. Driving License/Voter I Card/Aadhaar Card/ Bank passbook with photograph duly attested by any nationalized Bank (atleast, 3 years old)/Passport/or any other proof deemed fit by this office.
9. The DCP/Crime(HQ) of Delhi can terminate the services at any time without assigning any reason. In case any selected candidate wishes to quit, one month prior notice or surrender of one month remuneration in lieu of Notice is required.
10. In the event of selection/appointment the candidate shall have to submit an undertaking stating that he/she shall not stake any claim nor file any court case for regularization of service in any Court of Law.
